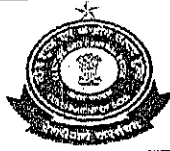

Sub.: Establishment – Chennai Custom House – Combined Graduate Level Examination, 2014 to the post of TAX ASSISTANT– Intimation of date for **Third and Final chance on 03.10.2016**– Reg.

1. I am directed to say that on the basis of results of Combined Graduate Level Examination, 2014, 219 candidates had been recommended by the Staff Selection Commission for appointment as TAX ASSISTANT in this Custom House, Chennai. The recommended candidates were called for document verification in the Month of April-May 2016. The absentees were offered a second chance on 08.08.2016. A **Third and Final Chance on 03.10.2016** is being offered to the candidates who didn't appear on second chance as well

2. The attestation form (To be downloaded from Chennai Customs website) should be submitted in DUPLICATE duly filled in by the candidates in all respects at the time of document verification without fail.

3. In this regard the candidates whose name is mentioned in the enclosed Annexure are directed to appear for Document Verification at Customs House, Chennai on **03.10.2016 at 10.00 AM**. Separate intimation letters have also been dispatched to the candidates. The candidates are directed to report on 03.10.2016 even if they do not receive the dispatched copies of the intimation letter.

4. The candidates are required to undergo a Medical Fitness Test at Government General Hospital, Chennai. On successful completion of Medical fitness, candidates are also directed to produce all original documents regarding age, educational qualification, Caste/PH/Ex-Servicemen certificates etc., to the undersigned positively on the following day for verification and return.

If the candidates fail to appear for document verification, their candidature will be cancelled and their dossiers will be sent back to Staff Selection Commission
