Attention of the Steamer Agents, Importers, Exporters and the Custom House Agents is invited to this Custom House Public Notice No. 43/2010 dated 21.05.2010 declaring the Container Freight Station of M/s.Thiru Rani Logistics Pvt. Ltd., CFS No.1, New North 200 Feet Road, Madhavaram, Chennai – 600 110 as "Customs Area" for handling Export cargo and Import FCL cargo and Public Notice No. 70/2013 dated 14.03.2013 for handling Import LCL cargo

In exercise of the powers conferred under Section 8 (b) of the Customs Act, 1962 the TMT 1 Warehouse (storage area of 16,000 sq.ft.) and TMT 5 Warehouse (storage area of 15,000 sq.ft.) both warehouses together having a total storage area of 31,000 sq.ft. is declared as "Customs Area " for the specific purpose of handling Export LCL cargo at the Container Freight Station of M/s.Thiru Rani Logistics Pvt. Ltd.

The procedure for dealing with import and export cargo are to be followed as laid down in Handling of cargo in Customs Area Regulations, 2009 and as laid down in the Public Notices issued in this regard by this custom House from time to time.

The movement of Export LCL cargo to the CFS is an optional facility available to the trading public.

The above facility and accompanying procedures come into immediate effect and shall remain in force until further orders.
