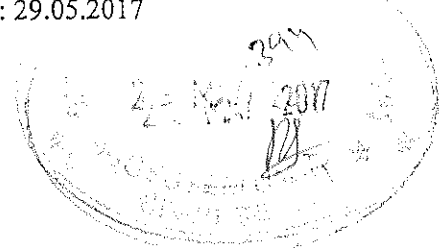

In exercise to the powers conferred under Section 45(1) of the Customs Act, 1962, M/s. Adani Ennore Container Terminal Private Limited (AECTPL) having their registered office at Adani House, Near Mithakhali Circle, Navrangpura, Ahmedabad, Gujarat – 380 009 is hereby appointed as the "CUSTODIAN" of Container Terminal (described below) within the notified Customs area of the Kamarajar Port, Vallur Post, Ponneri Taluk, Thiruvallur District- 600 120 for receipt , storage, delivery , dispatch or otherwise handling of import goods and export goods in accordance with the provisions of the Customs Act, 1962 read with Handling of Cargo in Customs Area Regulations 2009.

**DESCRIPTION OF AREA AND LOCATION:**

The Container Terminal with berth length of 400 Mtrs and total area of 2,00,000 Sq.Mtrs, located in the northern part of Kamarajar Port.


The Container Terminal with berths bounded at:

M/s.
