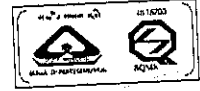

DESCRIPTION OF AREA AND LOCATION:

The Multi Cargo Terminal with berth length of 270 Mtrs and total area of 1,35,000 Sq. Mtrs, Located in the Northern part of Kamarajar Port.
